## Juniors Board Hire/Loan Agreement 2015/2016

Registered club members who have achieved the performance criteria, as set out below, in the previous Nipper season may apply to the North Curl Curl Surf Life Saving Club (NCCSLSC) Junior Activity Committee (JAC) for the hire/loan of one of the club's boards for the current Nippers season.

### 1. Performance criteria

1.1. The determination of the application will be at the discretion of the JAC but will be considered based on the following performance criteria: -

- registered club members in the U/9 to U/14 age groups who have completed and passed both preliminary proficiency and competition evaluation.
- attendance records at Sunday nipper activities
- attendance at board training sessions
- attendance at carnivals
- last season carnival results at Club, Branch & State

1.2. Due to demand, boards will not be issued to members in any age groups undertaking introductory training and who are not representing North Curl Curl Surf Life Saving Club in carnivals. Club boards will be made available during introductory training.

1.3. After completion of the introductory training and when an adequate level of competency has been achieved, applications from club members for the hire of boards will be considered based on the individual's:

- attendance at board training sessions
- commitment to compete at carnivals and
- co-operation with the trainers during training sessions.

### 2. Terms

2.1. The successful applicant: -

2.1.1. Must pay a non-refundable fee of: -

- \$100 for the use of a fibre glass board & cover for the season
- \$60 for the use of soft board for the season

2.1.2. Will have use of the nominated board for one season only

2.1.3. Bring the board to all nipper, club & carnival days

2.1.4. Return the board to the club at the completion of the current season

## 3. Allocation of Board

- 3.1. The Nippers Board and Equipment Manager in consultation with the 2015/16 coaching staff will select and allocate to the successful applicant.
- 3.2. Any issues re the allocation of boards should be emailed to Andrew Stuart ([stuff@curlydesign.com.au](mailto:stuff@curlydesign.com.au)). Any members who wish to swap their allocated board during the season are required to contact and seek approval from either the Equipment Manager or Andrew Stuart.

## 4. Conditions of Use

- 4.1. A club member will relinquish the rights to their allocated board (automatically lose their equipment allocation): -
  - 4.1.1. If the club member does not compete in 75% of club nominated board training sessions and surf carnivals including Branch and State titles.
  - 4.1.2. If the club member retires from competition.
  - 4.1.3. If a club member wilfully contributes to the destruction of the equipment.
  - 4.1.4. If the committee considers there to be improper use of the loan board.
  - 4.1.5. If the club member rides the board standing up which is dangerous to other surfers and the club member
  - 4.1.6. If the club member does not adequately maintain the board, and repair as necessary.
- 4.2. All boards remain the property of North Curl Curl Surf Life Saving Club.
- 4.3. The board must be maintained in good condition. Maintaining a board in good condition requires: -
  - 4.3.1. All damage repaired immediately.
  - 4.3.2. Store the Board inside out of the sun & weather, and use the padded protective cover for all fibre glass boards.
  - 4.3.3. Boards should not be left inside a car for long periods.
  - 4.3.4. Avoid strapping on top of each other.

4.4. You will be required to pay for any damage to a board as you would if you owned it. There is no "Free" repair with the exception of the board being damaged during the following: -

4.4.1. Carnival Competition

4.4.2. Sunday Nippers. Club members who hire boards must share their allocated board with other club members during Sunday nipper activities when requested by Age Managers.

If damaged during one of the above, you can organise repair by application in writing to the Finance Administrator Audrey King ([cheahaudrey@gmail.com](mailto:cheahaudrey@gmail.com)). Applications for repairs should briefly describe the location of the ding and where and when the incident occurred. A photo showing the damage to the board should be attached to the application.

Cost of repairs to the board for damage caused outside the Carnival Competition and Sunday Nippers is not covered by the club.
